## Letter of compliance and contributions

TWUSUPER is eligible to be nominated as a default fund as it meets the minimum statutory death insurance requirements for choice of fund. Once you have joined TWUSUPER (see below), TWUSUPER is able to accept ongoing superannuation contributions from you in accordance with the SIS Act.
