- it was your child's first day at primary or secondary school
- you first became eligible for a Centrelink Carer's Allowance.

The application must be received by us in time for it to reach the Fund's insurer within 60 days of the relevant Lifetime Event occurring or within 60 days of the date of the next member statement issued to you after the occurrence of the event.
